**Date:** Saturday February 6, 2010

**Place:** Glenwood Community Center

**Ages:** 8 and Under, 9-10, 11-12, 13-14, and 15-22  
Separate Male and Female divisions  
***Competitor's age as of 9/01/10***

**Divisions:** Novice = has never competed in a Jump Rope Competition  
Experienced = competed in a previous, official competition

**Events:** Separate Novice and Experienced Division in age-group and gender

**Speed:** 1 Minute (alternate feet for each rope rotation)

**Power:** Ages 14 and younger: 1 Minute (completed double unders are counted)  
Ages 15 and older: 1 Minute (completed **triple unders** are counted)

**Freestyle:** 45-75 second routine to music; ***CD's only for music***

**Awards:** Gold medal to winner of each event. Ribbons 2<sup>nd</sup> thru 6<sup>th</sup> place.  
Participation ribbons for all.

**Fees:** \$40 competition fee payable to Kangaroo Kids. All participants must be current AAU members - \$12 fee. Register for membership online at [www.aausports.org](http://www.aausports.org) or call 1-800-AAU-4USA. ***Membership number must be provided at time of registration.***

**Lunch:** Participants should plan to bring a bag lunch or be prepared to go out to buy lunch  
  
Complimentary lunch provided for judges and officials.

**Rules:** The competition will be conducted according to AAU Jump Rope rules. The official AAU Jump Rope Handbook (rulebook) may be obtained by visiting [www.aausports.org](http://www.aausports.org) and clicking on publications on Jump Rope page.

**Officials:** Each team is requested to supply a minimum of 1 certified judge for every 4 competitors, list of available judges should be submitted by registration deadline. All judges and officials must be AAU members.

**Registration Deadline: January 8, 2010.** Late registrations only accepted at the discretion of the Tournament Director with additional \$10 late fee.
