Raw adult lifters must use a singlet. Raw youth and teenage lifters can wear a T-shirt and non-baggy shorts above the knee. Must wear shoes or slippers (no socks or bare feet). Socks cannot touch the singlet or knee sleeves.
- \***Equipped Division**: Single ply squat suit, dead lift suits and bench press shirt. Knee wraps: 181 lbs.' down, 2 meter length, 198lbs and above can use 2.5 meter wraps. Wrist wraps: cannot exceed 1 meter in length and 8 cm. in width. Must wear shoes or slippers. Knee wraps cannot touch socks or suit.
